Lots 1 through 88, according to the plat recorded as Instrument No. 9503305004, Volume 58 of Plats, pages 289 - 301, records of Snohomish County, Washington.

The Rules and Regulations contain some restrictions that may not be found in the Amberleigh CC&Rs or in the Declaration of Covenants, Conditions and Restrictions of Mill Creek Community Association, including, but not limited to:

- 1. A restriction on outdoor decorations, such as birdbaths, fountains, bird feeders, sculptures, animal likenesses, wishing wells, elves, signs or other forms of "yard art" (except December holiday decorations).
